## Blood Tests

The **blood tests** we recommend help us minimize the risk of anesthesia, give us valuable information regarding the health of your cat, and provide you and us with peace of mind.

### Pre-anesthetic blood tests are important for the following reasons:

- Abnormal blood tests provide us with information about your pet's internal organs which may cause us to delay an anesthetic procedure until a later date, or pursue the medical problem causing the abnormal test
- Test results help us determine which anesthetic agents to use
- If blood tests are normal, we can move forward with the procedure with a greater degree of confidence
- Normal blood tests provide an excellent set of baseline values for your pet which are invaluable in the event that your pet becomes ill.

### FIV/FelV test:

- Provides us with valuable information regarding the FIV/FelV status of your cat. FIV and FelV are infections and contagious diseases that cause immune suppression. It is the recommendation of Enterprise Animal Hospital that the status of every cat be known. Depending on the lifestyle of your cat (if it spends time outdoors, unattended, and comingles with cats of unknown vaccination history), yearly testing is recommended.

- I authorize the recommended pre-anesthetic blood tests. Cost of pre-anesthetic blood test is:\_\_\_\_\_.

## Fluid Therapy

Administering fluid therapy during anesthetic procedures provides the following benefits for your pet:

- Intravenous fluid therapy helps maintain blood pressure, supports proper kidney function, aids in recovery from anesthetic and surgical procedures, and allows rapid access to the circulatory system if complications arise during the procedure.
